GENERAL TERMS AND CONDITIONS

Article I EXHIBITION ORGANIZER

agrokomplex NÁRODNÉ VÝSTAVIS, state enterprise

Article II AREA ALLOCATION

1. The exhibitor sends the application to sccf@siov.sk
2. Application for participation sent to sccf@siov.sk is binding for the exhibitor. The SCCF decides on acceptance, reduction or rejection of the application, taking maximum account of the exhibitor's requirements.
3. The Exhibitor undertakes to fulfill all obligations incurred by SCCF due to its participation and participation of its co-exhibitors as well as by its authorized companies for the construction of the exposition and the transport company. Any change is subject to SCCF approval.

Article III TERMS OF PAYMENT

1. Rental of the area is covered by the Ministry of Economy of the Slovak Republic. Implementation of the exhibition and its equipment in the range of offered standardized stands is covered by the State Institute for Vocational Education.

Article IV EXHIBITS

1. Exhibit means a product, goods or right to immovable property that is legally registered and displayed in the space provided by the SCCF and which corresponds to the fair nomenclature.
2. The exhibitor is obliged to notify the SCCF immediately of any changes to the exhibits.
3. The import and removal of exhibits is governed by AX instructions. AX shall charge handling and storage fees for the exhibits not removed until the dismantling date and shall not be liable for their loss or damage.
4. The exhibitor ensures that the exhibits are received. In the event that the exhibitor and his representative are not in place, the exhibits will be placed on the allocated exhibition area at the risk of the exhibitor. It is not allowed to carry exhibits during the course of the event.

Article V CONSTRUCTION AND INSTALLATION OF EXPOSURE, FITTING THE EXHIBITS

1. Assembly, dismantling and operating times are determined by AX. AX safety regulations are obligatory for exhibitors in the construction of exhibits and exhibitions.
2. Wall hydrants, fire detectors, fire extinguishers and other safety devices cannot be installed. Interventions in pavilion buildings or open spaces are prohibited. All works related to the modification of these areas must be ordered by the Exhibitor at AX.
3. The maximum height of the expositions in the pavilions is 3 meters and the open area is 8 meters. Derogations allowed exclusively by AX.
4. Water connections, el. Investors and telecommunication services must be ordered by AX with AX.
5. The Exhibitor is responsible for all equipment borrowed from AX and is obliged to return it to the undamaged after the Fair.
6. The Exhibitor shall be liable for damage to AX for damaged exhibition areas and AX equipment.
7. The "Rules for Assembly and Dismantling of Exhibitions at the Agrokomplex Nitra Exhibition Center" form an integral part of these general exhibition conditions.

Article VI ACOUSTIC ADVERTISING

1. The noise level in the stand shall not exceed 75 dB. If this limit is not met, the organizer may disconnect the stand from the el. connections.

Article VII PROMOTION, ADVERTISING

1. The Exhibitor is entitled to promote its products only in its own exposition.
2. All promotional media applied outside your own exposition must be ordered with AX.
3. The official catalog will be processed from documents supplied by the exhibitor.

Article VIII INSURANCE

1. Neither AX nor ŠIOV shall be liable to the Exhibitor or its co-exhibitors for any loss, destruction or any damage to the exhibits, equipment and equipment of the stand, goods, packaging or packaging material, whether or not the destruction or other damage occurred prior to, during, or after the fair or other AX event organized. For this purpose, the exhibitor will take out insurance with the insurance company of its choice.
2. Liability insurance for personal injury. Exhibitors who realize exhibition expositions themselves and firms providing for the realization of expositions are obliged to have insurance of liability for damages caused by their own activities during the assembly, during the fair and dismantling. They are obliged to prove this insurance upon request. In the event that this condition is not fulfilled or the entity is unable to prove this circumstance, AX is entitled to prevent it from entering the exhibition areas until redress.

Article IX TECHNICAL-SAFETY REGULATIONS IN THE AREA FIRE PROTECTION

1. Smoking is prohibited at the time of preparation, operation and dismantling in all pavilions. Exceptions are reserved areas that are equipped with ashtrays and do not store any combustible material. No flammable substances, explosives, acids and poisons must be stored in the pavilions. The exception is AX. All materials used to construct exposures must be non-flammable or impregnated against burning. The types and quantities of these materials used must be notified at the same time as the project is submitted.
2. At the same time, valid fire regulations must be observed.

Article X FINAL PROVISION

1. In the event that AX, as a result of its unrestricted circumstances (vismajor), cannot commence a fair or other accompanying event throughout its duration, or part thereof at all or part of the exhibition venue, it shall notify the exhibitor accordingly. All obligations incurred by AX by concluding the Exhibitor's Participation Agreement shall cease to exist. In this case, the exhibitor is not entitled to any compensation for the damage incurred. AX is entitled to withhold an appropriate portion of the fees already paid by the exhibitors.
2. The exhibitor may file a claim for the work and services provided by AX with the responsible employee in writing without undue delay no later than the day before the end of the fair, otherwise the right expires.
3. Unless otherwise stated, AX shall be entitled to exclude the Exhibitor from any further participation in the Fair or other accompanying event in the event of any of the provisions of these Terms and Conditions. In such a case, the Exhibitor is not entitled to any compensation for any damages and to the return of the invoice paid in the meantime.
